Greetings,

The Minnesota Department of Transportation – Metropolitan District is soliciting Letters of Interest (LOI) from companies interested in providing Design-Build services for the design and construction of Interstate 35W between Cliff Road in Burnsville, Minnesota and 106th Street in Bloomington Minnesota. The proposed construction will include the replacement of Bridge 5983 over the Minnesota River, grading and surfacing of Interstate 35W, drainage, retaining wall construction, lighting, signing, and a traffic management system.

The project is currently scheduled for a March of 2019 letting. There is a possibility that this project will be advanced one year to a March of 2018 letting. We are progressing as if the project will be advanced the one year and beginning the development of the documents required for the design-build contract. The decision of the project's advancement will be made prior to the issuance of the Request for Qualifications and subsequently the Request for Proposals.
